PARADE INFORMATION

You must register no later than **NOON** on **Friday, October 24th** at the Flora Chamber of Commerce office at 223 W. Railroad St., **TUES/WED/FRI between the hours of 8:00 a.m. and 5:00 p.m.**

You must have a **Registration Number Card** in order to be judged in the parade, and have a place in the lineup. You will be placed in line per the staging director instructions based on arrival to area and whether there is music in your entry.

Staging area will be given the day you register - parade numbers will be given the day of the parade when you check in. Location of Staging Area based on type of entry, not type of category.

Please be respectful of your staging area, and leave it in the same condition it was in when you arrived, including picking up any decorations, candy, trash, or anything left by any participating animals. Please do not leave cars parked in staging areas.

For public safety, you also agree to not throw candy or any items from any vehicle or float. If caught throwing anything from the vehicles, you understand that you can be disqualified from judging. You also agree that the driver of the vehicle will stay in the vehicle during parade route.

Please help us keep the parade moving smoothly for everyone's enjoyment. If you've been kindly reminded by local law enforcement or a Chamber Director/Volunteer to continue moving, and the issue persists, we may need to ask you to exit the parade to ensure the event stays on schedule.
